1. **What does Business-Phones Privacy Policy cover?** All the personal information we collect is noted on your profile page. That includes your name, email, date of birth and biographic information. The personal information that you provide is used for Registration purpose. In order for you to participate in Business-Phones discussion you must complete a registration form. As part of registration form, we require your email

address.

2. **Profile Information** Business-Phones allow other users to browse your full name, instant messaging URL, and other details within your member profile should you provide this optional information. Business-Phones allows for the RSS syndication of all of its public content within the website.
3. **Cookies** Cookies are alphanumeric identifiers that we transfer to your computer's hard drive through your Web browser to enable our systems to recognize your browser in order to check in if you are logged in or out. All the other information is located in Business-Phones server. Some of our business partners may use cookies on our website (for example advertisers). However, we have no access to or control over these cookies.
4. **Third-party Advertisement** We allow third-party companies to serve ads and/or collect certain anonymous information when you visit our web site. These companies may use non-personally identifiable information (e.g., click stream information, browser type, time and date, subject of advertisements clicked or scrolled over) during your visits to this and other Web sites in order to provide advertisements about goods and services likely to be of greater interest to you.
